1. Motion to approve a bid for the parking lot lights – Supervisor Thorsby

Trustee Westenbarger secured the bids for the parking lot lighting and briefly went over the bids with the Board of Trustees stating he would recommend the bid from Weinstein Electric.

TRUSTEE WESTENBARGER MOVED, supported by Treasurer Peck to award the bid to Weinstein Electric in the amount of \$15,900.00 and to replace existing wall-mounted light fixture at east end of building with new LED fixture for \$598.00.

Amendment Terms as follows:

• Section 2 of the Second Amendment to Ground Lease Agreement provides for five (5) additional terms of sixty (60) months and two (2) additional terms of approximately five

- (5) years each (each a "Renewal Term"), with a final Lease expiration date of March 31, 2044. The Lease will be amended by adding six (6) Renewal Terms(s) of five (5) years each. Upon execution of the Lease Amendment, the new final Lease expiration date will be March 31, 2074.
- Effective April 1, 2044, monthly rent will escalate 15% every 5 years
- \$3,000.00 bonus payment

TRUSTEE WESTENBARGER MOVED, supported by Treasurer Peck to approve the amendment to the lease from Crown Castle for the cell tower.
