EXPIRATION OF PERMITS: A permit remains valid for one year as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated. Permits may be extended if a satisfactory degree of progress in construction is shown. All request for extensions shall ber in writing.

Section 23a of the state construction act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a structure. Voilators of section 23a are subject to civil fines.
