SUBJECT: Draft Genesee County Solid Waste Management Plan Amendment

Attached is a draft copy of Genesee County's Solid Waste Management Plan (SWMP) Amendment. **This Draft copy should be made accessible to the public for review beginning on March 1, 2023, through May 30, 2023.** Additionally, please make a digital copy available on your website. The Genesee County SWMP is required by the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to ensure that the county can properly dispose of waste for the next ten years. More specifically, the SWMP describes materials management data, public input, deficiencies, goals and objectives to enhance materials management practices, solid waste facilities, as well as implementation strategies to improve Genesee County's solid waste system.
