An official when out of the office for four (4) consecutive business days, to provide for the continuity of the Township business, should designate a specific individual to open the Official's mail. The Official could exempt any mail which is expressly designated personal and/or confidential. All checks cashed or other payments received by mail delivery shall be accounted for in accordance with Township Policies."
