NEW BUSINESS:

1-a. <u>Group Appointment – Police Study</u>

GARDNER MOVED, seconded by Minaudo that:

"Whereas, the Township has suffered reduced tax revenues from the police millage such that we have had to reduce the amount of police services, we provide to our residents in order to stay within our budget; and

Whereas, the Township should explore the best way to provide the most police coverage to the residents of the Township with the money we have available; and

Whereas, there are many ways to provide police services, including through our own department and through joint authorities or through contracting with other departments; and

Whereas, the Governor and Legislature have asked communities to explore ways to efficiently provide public services through joint efforts.

Therefore, I move that the Board appoint an information-gathering group made up of the Supervisor, Treasurer, and the Clerk, and that group explore the alternatives for providing police services to the Township's residents and bring a report back to the Board for review at the Board's February 9, 2012 meeting. The alternatives to be explored should include continuing our own Department and/or contracting with the County Sheriff."

DISCUSSION:

It was ask why it wasn't mentioned about contracting with Montrose or the City of Flushing. The Supervisor mentioned that he had talked with the two (2) Municipalities and they weren't interested. Clayton Township would be interested but their perimeters would be prohibited because they pay their officers \$18 per hour and would not want to increase the cost; the retirement is a 401K; and a few other issues that would not be approved. It was ask if we went with the Sheriff Department, would they (Sheriff Department) hire the Flushing Township Police Department? Supervisor **PECK** stated the Flushing Township Police Officers would be able to apply to the Sheriff's Department.

PURKEY had received a call from one of the Flushing City Counsel people who stated they had thought about making Flushing Township an offer; City Manager Dennis Bow stated the offer was not true.

The Clerk recommended that in the last line of the last paragraph "The alternatives to be. . .contracting with the County Sheriff" be **changed** to "The alternatives to be explored should include continuing our own Department and/or contracting with the County Sheriff."

GARDNER MOVED, seconded by Minaudo to change the last sentence to read "and/or" instead of "and".

1. SUPERVISOR'S COMMENTS:

- a. The Supervisor chose the Personnel Committee who will do the Police Study; all the details will be assembled and brought back to the February 9, 2012 Board Meeting. The Committee needs the Plante and Moran Study to proceed.
- b. Compensation Commission MTA "Authorities and Responsibilities" (Page 190) which states:
 - "The commission determines the salaries of elected township officials, and they are final, unless the township board rejects them by a resolution adopted by two-thirds of its members. If the commission's proposed salaries are rejected, the existing salaries continue. The compensation commission cannot decrease the salary of an elected township official during his or her term of office (MCL 41.95) The salary determined by the commission becomes effective at the beginning of the next fiscal year of the township."
- c. **NOECKER** stated the Supervisor, Clerk, and Treasurer just received a cost of living raise of \$1,900; the Trustees received \$333 for their cost of living. The cost of living adjustment was put into existence when the last Compensation Commission was disbanded in 2006.
