#### VI. NEW BUSINESS

- 1. Discussion and possible motion on CHAPTER 36 ZONING ORDINANCE SEC 36-419 FARM ANIMALS AND HORSE ORDINANCE.
  - Requires a minimum of 2 acres to have one hooved animal on your lot. And the housing ordinance for animals would be in conjunction with as well.
  - Residents can have 20 chickens (No roosters on less than 2 acres) on 2 acres, 10 on one acre and 5 on a half-acre. Wording was discussed to make this more specific.

After much discussion on the following items in the proposed CHAPTER 36 ZONING ORDINANCE SEC 36-419 FARM ANIMALS AND HORSE ORDINANCE. The following motion was made.

TREASURER PECK MOVED, supported by Commissioner Moon to approve CHAPTER 36 ZONING ORDINANCE SEC 36-419 FARM ANIMALS AND HORSE ORDINANCE to be sent to the Board of Trustees for approval with addition of the following sentence: For non-hooved animals, the total number of allowed animals shall be proportional to the first whole two (2) acres of land based on animal units. For example: 2 acres = 20 fowl, 1 acre = 10 fowl, 0.5 acre = 5 fowl. No roosters will be allowed on properties under 2 acres.

• Soil on property must stay on property.

• Consider addition of a diagram on the 2<sup>nd</sup> page indicating the components of a Wind

Park.

• Specify on 10<sup>th</sup> page that any replacement trees must be replanted on the same parcel as

the removed trees.

• How the clean up after land is no longer being used and the turbines are decommissioned.

For example, concrete disposal and reconstruction of property to its original state using

material approved by the Township.

Are there any restrictions for wildlife areas or any other regulations?

Commissioner Mills informed Planning Commissioners that he currently was under DTE, Wind

and Solar Contracts.

After Much discussion it was decided to continue working on the New Commercial Wind

Energy Ordinance for Charter Township of Flushing, and present revisions at next Planning

Commission Meeting on July 8th, 2024.
