NEW BUSINESS

1. Pavement of Coldwater Road

GARDNER MOVED, seconded by Minaudo to approve \$130,700.50 for the repair and chip and seal of Coldwater Road

DISCUSSION:

The repair/paving of Coldwater Road will be similar to the repair of Stanley Road from Seymour Road to Duffield Road. Coldwater Road will be paved from Seymour Road to M-13. The chip and seal will take place next year. The price is \$130,700.50. The job will be a repair and cap and will come out to the edge of the road. It was mentioned to classify the Coldwater Road job as a repair and chip and seal; there is no way to pave a road for \$130,000. It was mentioned that the Township cannot afford to pass up a Cadillac job (mill, resurface, rebuilt) for 3 ½ miles at the particular price. The project will last for five (5) years. The chip and seal will be put on next year at a cost of \$18,000 per mile and will give another three (3) years.

There could be an additional cost of \$5,000 to \$8,000 for drain work on Apple Blossom Drive/Spy Del.

- 4. **GARDNER:** expressed the same thought as Minaudo.
