**GARDNER MOVED**, seconded by Purkey to amend the motion on the floor to remove item "J" under New Business.

## ATTORNEY'S OPINION:

Mr. Larry Birchmeier, through his attorney, made a request at the last meeting to be placed on the next Agenda; the Supervisor agreed to allow Mr. Birchmeier to speak to the Board for no more than ten (10) minutes. The request wasn't able to take place at the April Board Meeting and was rolled over to the May Board Meeting.

Mr. Birchmeier was a former member of the Parks and Recreation Committee. Over the past several months Mr. Birchmeier has requested information regarding Policies and Procedures, and the selection of committee members for the operation of the Park Committee. Attorney Moulton has supplied the requested information to Mr. Birchmeier's attorney. The request has continued from Mr. Birchmeier to be placed on the Board of Trustees Agenda.

In order to bring the issue to a resolution, Attorney Moulton recommended the board take a very uncharacteristic action and allow an individual to address the board outside the *Public Comment* section to find out what the issue is regarding Mr. Birchmeier's request to speak to the board for no more than ten (10) minutes.

It was a concern by some board members that if the board allowed one individual to speak, it would set a precedent and other individuals would seek the time also; Mr. Birchmeier's request will be an exception. Attorney Moulton did advise Mr. Birchmeier's attorney, which was the understanding at the last (April) board meeting, that Mr. Birchmeier would be on the next Agenda. Since the issue has been going on for some time, the Attorney felt there could be a closure to the issue by allowing no more than ten (10) minutes for Mr. Birchmeier to speak.

When a board member places an item on the Agenda, felt that when an item was placed on the agenda, a document had to be turned in to the Clerk with the request; would like to see a written request from Mr. Birchmeier to the board members. There has also been requests from others that would like to be placed on the agenda for next month to rebuttal the issue.

The Open Meetings Act controls what takes place at the Board Meetings. It was ask why the issue was not settled at the Parks and Recreation Committee Meetings.

## 2. Flushing Township Chloride Treatment

**GARDNER MOVED**, seconded by Minaudo to go with thirty-eight (38) percent of chloride.

#### **DISCUSSION:**

Other counties use brine but it was determined that Genesee County could not use brine so chloride will be used in Genesee County.

There will be three (3) applications: the first (1<sup>st</sup>) application will be paid for by the County; the second (2<sup>nd</sup>) and third (3<sup>rd</sup>) application will be paid for by Flushing Township. Flushing Township has a choice of going with thirty-five (35%) or thirty-eight (38%) percent calcium at 2,000 gallons per mile. For thirty-five (35%) percent the cost is \$11,865.00 for each application.

It was recommended by the Supervisor to go with the higher percentage of chloride.

1-b. First Reading of AN ORDINANCE TO AMEND SECTIONS 13.1-21 OF THE CODE OF ORDINANCES TO CLARIFY THE STATUS OF THE FLUSHING TOWNSHIP PARKS AND RECREATION COMMISSION AND TO REGULATE THE LAUNCHING AND RECOVERY OF WATER CRAFT.

**MORFORD MOVED,** seconded by Purkey to accept AN ORDINANCE TO AMEND SECTIONS 13.1-21 OF THE CODE OF ORDINANCES TO CLARIFY THE STATUS OF THE FLUSHING TOWNSHIP PARKS AND RECREATION COMMISSION AND TO REGULATE THE LAUNCHING AND RECOVERY OF WATER CRAFT, which is the first reading.

#### **DISCUSSION:**

Two issues will be addressed in one ordinance both of which govern Parks in general. The existing ordinance uses "Commission" which is inappropriate and not sure how the "Commission" came about; the first part of the proposed ordinance amends the ordinance to remove the word "Commission" and replaces it with "Committee". Flushing Township actually has a "Park Committee". The word Commission brings a lot of things with it that are not what Flushing Township actually has.

The proposed language for Section 13.1-33 the Launching and recovery of water craft. Water craft is defined as a non-motorized craft in excess of twenty (20) feet in length. The craft can be launched and recovered at an area designated at the river site in

the Flushing Township Nature Park (Nature Park) to be done during park hours. Vehicles and trailers used to being the craft to the park shall not remain at the park after hours.

There were also issues about traffic, but they have been addressed in the previous ordinance.

The repair cost for each catch basin will be between \$2,800.00 and \$5,600.00. The total cost for repairing the drain and the two (2) catch basins will be \$26,700.00 which will come out of Road Maintenance.

The safety issue has come up several times in the past in the office and at board meetings so something should be done. The idea of cameras has been discouraged by the

office employees. Details will be brought back to the Board. The Supervisor reminded everyone to be quiet during the meetings; if the talking continues, the Chief will remove the individual from the meeting.

The Police Department has went from thirteen (13) to six (6) police officers so it would be a way to be a force multiplier by being involved. The cost would be \$4,964.45 for six (6) months. There was a discussion as to how long the township had not belonged to F.A.N.G. If the money was tight years ago, then the money would also be tight now. The Federal government has also taken care of the cost of cleaning up meth labs instead of the township.

#### **BOARD COMMENTS:**

- 1. **GARDNER** has spoken with Mr. Birchmeier several times and it is not the intent of the Board to keep him from being an Agenda item, but once someone is given ten (10) minutes to speak, the right should be given to everyone. Gardner, or three (3) members, would be willing to meet with Mr. Birchmeier, but when it comes to placing Mr. Birchmeier on the Agenda, Gardner is opposed to that.
- 2. **NOECKER** felt that Mr. Birchmeier should not take this personally; when Noecker left the Parks and Recreation Committee, Noecker recommended Mr. Birchmeier since he had a strong feeling for the park. There are a lot of hot issues in the township that are contested but the Board of Trustees was elected to make tough decisions. The Park Committee was never in a position to re-hire, give raises, or extend hours; only the Board of Trustees can take that position. Noecker recommended on several occasions that Mr. Birchmeier draft a letter and express his intentions in order to get on the Agenda. Noecher would be willing to meet with Mr. Birchmeier and/or his attorney.
- 3. **MORFORD** congratulated former Supervisor Jerry Woods for the new picture hanging on the wall in the Board Room with all the other Supervisors. Morford would like to have the large 2008 Board of Trustees picture returned to her office. The picture was made to hang on the wall in the Board Room with all the other elected officials.
