<u>pages 10 and 11</u>: Format of the Agenda - 1) letter E, "Corrected Minutes" will be eliminated; 2) sub-categories under V."Reports" will be eliminated; 3) "Other Reports" will be eliminated; the "Financial Report" will be given under "Reports." "Public Comments" will be listed before "Board Comments." The "Amended Agenda" will be stapled to the proposed Minutes and approved at the same time.

page 15: should start with number 3.

<u>page 17:</u> number 2, line 2, "to defend the lawsuit"... **should state** "if it is determined the lawsuit claim requires legal defense"; number 4, line 4, "the press or other third parties **shall** be directed to the chairperson".....

The format for the Agenda is a general guideline for the future.

page 18: "Matters of Litigation" was removed.

<u>page 38:</u> "Expenditures" consisting of three (3) components: Expenditure Authorization, Administration Expenditures, and Emergency Expenditures are without change at this time.

page 47: "The Nature Park Pavilion. . ." There is a detailed ordinance that governs the Nature Park and does not prohibit allowing group use of the park space. A policy needs to be put into effect for the use of the park and could be addressed at a later meeting. The policy would give the Board the ability to set a fee for the use of the Nature Park.

page 54: V. Clerk's Duties: letter A - the Board should be able to put their hands on all documents; letter G – "Prepares minutes for Board, annual meeting; Charter Townships

do not have annual meetings. Letter G was changed to "Prepares minutes for all Board Meetings." It was recommended to return to the original policy and not deal with a large number of policies at one time. The policies have to be tailored to the number of employees.

page 55: VI. Treasurer's Duties: because of the investment climate, some of the issues cannot be accomplished; letter L is almost impossible for a small township. The township is required to invest in certain secured investments which are part of the Financial Policy. Suggested Recommendations: The Treasurer would like to go back to the original duties of the Treasurer and work forward. It was recommended to take letter L and have it read "Prepares Quarterly Investment Report." Letters M through S were already in the *Policy and Procedures Manual*. It was recommended to place "VI. Treasurer's Duties" on the September Agenda. Letter L will be removed. Per Attorney Moulton, letters A through I were the original Treasurer's Duties; letters J through S are new duties. <u>FINAL DECISION</u>: the Treasurer's Duties will be put on the next Agenda under "Unfinished Business" and if there isn't time to discuss, it will be brought up at a later time.

(<u>SUMMARY PER ATTORNEY MOULTON</u> - Everything under *Authorities, Duties, Limitations* will be as in Draft 2, except with respect to the "Treasurer's Duties," in which case, items A through J will be included with letters K through S will not be included and can be taken up at a later date.

page 55: VII. Trustee's Duties: there are no changes to this section.

**MARTINSON MOVED,** seconded by Minaudo, that the Board delegate to Trustee Martinson and Lorraine Nemecek, under the watchful eye of Attorney Moulton, the authority to edit Part 1 of our *Policy and Procedure Manual* without bringing the editorial corrections back to the Board for approval.
