BACKGROUND HISTORY:

ATTORNEY STEVE MOULTON EXPLAINED THAT A TWO (2) PAGE OPTION SUMMARY HAD BEEN PREPARED PRIOR TO THE MEETING BY TRUSTEE MINAUDO AND DESIGNATED AS "POLICE SERVICES OPTION". THE DOCUMENT HAD BEEN PLACED IN THE TRUSTEES PACKETS. LATE THIS AFTERNOON, TRUSTEE MINAUDO HAD AN OPPORTUNITY TO DISCUSS THE OPTION WITH MICHAEL EDMUNDS, THE ATTORNEY THAT IS REPRESENTING THE TOWNSHIP IN DEFENSE IN BOTH THE PATROL OFFICERS LAWSUIT AND THE LAWSUIT FILED BY BRIAN FAIRCHILD. TRUSTEE MINAUDO EXPRESSED SOME COMMENTS THAT WERE MADE DURING THE INTERCHANGE WITH ATTORNEY EDMUNDS. ATTORNEY MOULTON INDICATED TO TRUSTEE MINAUDO THAT IF THE PRESENTATION "POLICE SERVICES OPTION" LISTED UNDER "NEW BUSINESS" 1a(1) WOULD INCLUDE THE COMMENTS MADE TO OR RECEIVED FROM ATTORNEY EDMUNDS THEN IT COULD NOT TAKE PLACE AS PART OF THE OPEN

MEETING. IT WOULD HAVE TO BE DONE IN A CLOSED SESSION. IT WAS ATTORNEY MOULTON'S OPINION THAT TRUSTEE MINAUDO WAS GOING TO MAKE AN AMENDMENT TO AMEND THE AGENDA TO ASK THAT ITEM 1A(1) BE DISCUSSED IN CLOSED SESSION. ATTORNEY MOULTON DIDN'T REALIZE THAT THE AMENDMENT WOULD BE EXTENDED TO INCLUDE ITEMS 2 AND 3.

MINAUDO struck his motion.

DISCUSSION:

There is approximately \$33,000 in the PEG Account. It was asked why the ceiling and floor tiles have to be replaced; per Mr. Gerald Smith of Comcast the tiles are under the guidelines and would be covered under the PEG Funds.

NEW BUSINESS:

1-a. <u>Discussion on Police Litigation Issues:</u>

GAGE MOVED, seconded by Lee to include a number of related issues to be discussed before making <u>separate motions</u> for discussion by the Board.

- 1. The Board affirmatively decided not to appeal or take other action to contest the arbitration award issued January 23, 2013 by Joseph P. Girolamo.
- 2. The Board immediately proceed to comply with the arbitration award and:
 - reinstate the three (3) police officers, Louis Cook, Mark Bolin and Andrew Owen, effective March 18, 2013, with the officers' employment through March 31, 2014, governed by the terms of the Collectible Bargaining Agreement between the Township and the Police Officers Labor Council incorporating the agreed changes and the changes required by the Act 312 Arbitration Decision issued June 13, 2012;
 - that the officers be paid back-pay in accordance with the award, as soon as the exact amount due to each officer under the award can be determined and agreed between Township and each officer;
 - that the supervisor and the Township attorneys are authorized to enter into discussions with the Labor Council's representative, Lloyd Whetstone to finalize the agreement and that the Township's attorneys be directed to prepare the final agreement for signature.
- 3. The board authorize the supervisor and the township's attorneys to negotiate with Brian Fairchild and his attorneys his possible employment as police chief under terms of a written agreement between the Township and Brian Fairchild with discussions to include possible settlement of Brian Fairchild's pending wage and hour dispute, arbitration and lawsuit. Any employment agreement and/or settlement agreements subject to Board approval.
- 4. That pending possible employment of Brian Fairchild, the supervisor, with the agreement of Brian Fairchild, be authorized to enter into an immediate agreement with Brian Fairchild to compensate him for services provided to reinstate the Township Police Department, including certification, acquisition of necessary equipment, training, scheduling and all other administrative matters necessary to the operation of a Police Department.
- 5. That the Township's insurance carrier, EMC, and agent Geoffrey Lansky, be directed to add to the Township's existing insurance coverage, law enforcement coverage, effective March 18, 2013.
- 6. That the existing contract with the Genesee County Sheriff for law enforcement services be extended through April 30, 2013, and that the supervisor take any further action necessary to have the contract extension approved by the Genesee County Board of Commissioners at its March 20, 2013, meeting.

INFORMATION HAS BEEN SUPPLIED BY FLUSHING TOWNSHIP ATTORNEY STEVE MOULTON, FLUSHING TOWNSHIP LABOR ATTORNEY STEVE SCHULTZ, AND EMC INSURANCE ATTORNEY MICHAEL EDMUNDS WHO IS REPRESENTING THE TOWNSHIP IN THE LAWSUITS.

The recommendation from Attorney Steve Moulton to the Board is to accept the decision of the Arbitrator and go forward on the basis, comply with the ruling, and to do that it requires to reinstate the three (3) officers and to pay the back-pay. To do that requires:

- reconstituting the Police Department and to do that effectively you would need at least one (1) administrative officer. There have been numerous discussions regarding the possibility of Brian Fairchild being employed as the administrative officer most likely as the Police Chief.
- on conversations with Mr. Fairchild's attorney, he would be willing to do that and it would all be subject to negotiating a separate written agreement with Brian Fairchild with terms acceptable to both Mr. Fairchild, the Township Board, and the two (2) attorneys.
- There are three (3) proceedings involving Brian Fairchild in the Township at this point. There is a 1) Wage and Hour Dispute, 2) an arbitration that is essentially very similar to the one that the patrol officers brought the attorneys agreed to put Mr. Fairchild's arbitration on hold pending results in the Patrol Officers arbitration proceeding. The decision in the arbitration proceeding involving the patrol officers is not determinative of the outcome of the proceeding involving Brian Fairchild because the factual situations are significantly different. The Wage and Hour Dispute, the Arbitration, and the pending Lawsuit. Brian Fairchild's last day of employment was in June because he served out working as a school liaison school resource officer until the end of the 2012/2013 school year. The amount of back-pay issue in regards to Mr. Fairchild is significantly less than the back-pay issue for the patrol officers who were off work several months earlier.
- If the Township Board decides to go forward in the particular fashion, police protection needs to be continued until we can implement a functioning police department to some degree. The contract needs to be extended with the Genesee County Sheriff; the existing contract term was extended from its original expiration date to March 31, 2013. After having some tentative discussions with the Township Board it doesn't look like a contract could be implemented before March 31, 2013. There have been discussions with Undersheriff Swanson and Sheriff Pickell; we believe the shortest period of time that would effectively address the township's police concerns are April 30, 2013. There is a proposed tentative agreement which will be placed on the Agenda for the Genesee County Board of Commissioners for their March 20, 2013 Meeting.
- If the Police Department is reinstated, the insurance coverage would have to be reinstated with the current carrier which is a simple procedure directing the insurance be taken care of. If an immediate agreement cannot be reached with Brian Fairchild, under the terms of the written contract where he is actually employed as a police chief or administrative officer, possibly he would agree pending as long as it looked like it might occur, to provide services with regard to what needs to be done to reinstate the Police Department. Police Departments have to be certified. There are other things that have to be done to implement an active Police Department; Brian Fairchild has the expertise to accomplish that as efficiently as anyone else that the Township could contract with.

DISCUSSION:

During a telephone conversation where the Supervisor and Treasurer were present, the statement was made that it would be very easy to accomplish the

reinstatement process for the Police Department as long as there was a Chief in place; the certification can be done administratively and wouldn't take very long to accomplish. If the decision was made by a majority of the Board to bring back the Police Department, Brian Fairchild could look into the matter of certification and other matters that needed to be put in place. Some Board Members felt the situation had been inherited and wanted to know what the lowest cost would be to restore police services and to prevent paying for two (2) sets of police services simultaneously. The Sheriff Deputies gave great service, same as the prior Flushing Township Police Department, but under the situation the only option would be to bring back the Flushing patrol officers.

It was mentioned by a Board Member who was saddened that Trustee Minaudo's proposal couldn't have been reviewed and tweaked to make it work for the Township.

A lot of documentation has been reviewed, discussed, phone calls made, etc. in order to make a very sound decision. The Board has to make a decision and stand by it.

Every day that a decision is not made, the township is paying for two (2) police services; it makes sense to get services where the township is only paying for one (1) service. The Board has been working on a decision for months; Trustee Minaudo's issue was brought up just recently. We need to move ahead. Recently a Board Member saw a sign that read "The decision that you make today will affect you tomorrow."

1-i. <u>Indemnification Policy for Elected Officials</u>

LEE MOVED, seconded by Morford to adopt the "Indemnification Policy for Elected Officials".

DISCUSSION:

It was requested to have Attorney Moulton explain a, b, and c, of the Indemnification Policy.

PER ATTORNEY MOULTON: The Township will indemnify and hold harmless any elected official for any damages or claims asserted against the elected official as a result of that official performing his elected duty. There are some exceptions to that matter. A township is not going to back up or indemnify an official for:

- a) a breach of the elected officials duty of loyalty to the Township or its residents
- b) acts or omissions not in good faith or which involve intentional misconduct or violation of law
- c) a transaction from which the elected official received or derived an improper personal benefit as a result of using his elected position.

The above are types of conduct that anyone would not want their governmental entity to cover or insure against for the benefit of an elected official. The Acts don't happen by mistake, they are more than just negligence or misfeasance in office, they are the types of things that require an intentional, knowing, lawful act on the part of the official. As a Board you are not going to agree to stand behind that type of individual and the insurance wouldn't cover the matter either.

It was also ask to have Attorney Moulton explain "breach of elected officials's duty of loyalty": every decision that an elected official makes has to be guided by good faith and in the best interest of the township. The township has a "Conflict of Interest" Policy and it is also in statute. Example: If a decision comes before the Board to purchase a piece of property, and the Board Member's brother-in-law owns the property and is going to give the Board Member half of whatever he receives if the township purchases the property. The Board Member will be holding out for a higher price. The loyalty in all the decisions Board Members make has to be in the best interest of the township. If there is a conflict between what works for the Board Member personally and what works for the township, the Board Member has to inform the Board and abstain from a decision. If the decision requires a vote or if it is something that the Board Member will be dealing with in the course of his/her job, the Board Member should bring the conflict to someone's attention.

The Treasurer complimented Attorney Moulton for a well written policy.
