TUESDAY, NOVEMBER 7, 2023
GENESEE COUNTY, MICHIGAN**

TO THE QUALIFIED ELECTORS:

A City General Election and Special Election will be held in several precincts of the Cities and Townships of the County of Genesee, Michigan.

PLEASE TAKE NOTICE that any qualified elector who is not already registered, may register to vote at their local City or Township Clerk; a Secretary of State Branch office, or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the City or Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local City or Township Clerk is **Monday, October 23, 2023**.

Beginning October 23, and continuing through 8:00 p.m. on November 7, 2023, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the office of their local clerk.

Ballot proposals appearing on the ballot are as follows:

City of Montrose- Public Safety Millage, for a period of five years beginning on July 1, 2024, renew a public safety millage of 3.846 mills per \$1,000 of taxable valuations of state taxable value which is estimated to produce \$121,095.13 of collections in the first year

Grand Blanc Township- Police Services Millage, replace the previously approved 1.0 mill due to expire in 2023, reduced to .9783 mills by required millage rollbacks, with an increased levy of 1.5 mills (\$1.50 on each \$1,000.00 of taxable value) for a period of six (6) years, 2023 to 2028, inclusive. The Township will not collect the previously approved .9783 mills due to expire in 2023. The estimated revenue the township will collect if the millage is approved and levied in 2023 is approximately \$2,531,742.84.

Montrose Township- Solar Ordinance 153.16/153.219(AA)- An Ordinance Amending the Montrose Township Zoning Ordinance by the Amendment of Sections 153.006 and 153.219(AA) to Provide for the Definitions, Regulation and Process of Acceptance of Applications and Permits, and the Construction and Operation of, Solar Development within the Charter Township of Montrose, and to Provide the Penalties for the Violation Thereof

Bentley Community School District- Building and Site Bond Proposal, 2.10 mills (\$2.10 per \$1,000 of taxable valuation) for a 1.10 mill net increase over the prior year's levy. The bonds may be outstanding for a maximum of twenty one (21) years, exclusive of any refunding. The estimated simple average annual millage anticipated to be required to retire this bond debt is 3.04 mills (\$3.04 per \$1,000 of taxable valuation).

Carman-Ainsworth Community Schools- Headlee Override Operating Millage Tax Levy, not to exceed 2.3490 mills (\$2.3490 on each \$1,000 of taxable valuation) for a period of twenty (20) years, 2024-2043, inclusive. It is estimated that the revenue the school district will collect, if the millage is approved and levied in the 2024 calendar year, shall be approximately \$1,859,350.

Fenton Area Public Schools- Bond Proposal, not to exceed One Hundred Twenty-Two Million Five Hundred Fifty Thousand Dollars (\$122,550,000). The estimated millage that will be levied for the proposed bonds in 2024 is 2.30 mills (\$2.30 on each \$1,000 of taxable valuation) for a -0- mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-five (25) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 4.16 mills (\$4.16 on each \$1,000 of taxable valuation).

Goodrich Area Schools- Sinking Fund Millage Proposal, levy not to exceed 1 mill (\$1.00 on each \$1,000 of taxable valuation) for a period of 10 years, 2023 to 2032, inclusive.

Montrose Community Schools- Bond Proposal, not to exceed Fifteen Million Nine Hundred Thousand Dollars (\$15,900,000). The estimated millage that will be levied for the proposed bonds in 2024, under current law, is -0- mills (\$0.00 on each \$1,000 of taxable valuation) for a -0- mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-eight (28) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.49 mills (\$2.49 on each \$1,000 of taxable valuation).

Swartz Creek Community Schools- Operating Millage Renewal Proposal, rate limitation of 18.8218 mills (\$18.8218 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Swartz Creek

Community Schools, Genesee County, Michigan, be renewed for a period of 10 years, 2025 to 2034, inclusive. The estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2025 is approximately \$6,637,027 (this is a renewal of millage that will expire with the 2024 tax levy).
